1. Daario van Dream Gait will be available for live cover at Sanderson Ranch, Riverton, WY April 1 - June 15, 2023.
2. Upon completion of this contract, a non-refundable booking fee of \$100 is due to reserve your mare for 2023. The remaining balance of \$700 MUST be paid before, or when, mare is delivered.
3. Daily mare care fees are due when mare is picked up as follows: \$10/day dry \$14/day wet mares starting day of drop off to day after last cover. Daily mare care fee starting 24 hours after day of last cover is \$20/day.
4. Mare must be halter broke and safe to handle by most reasonable standards.
5. A pre-breeding exam by a licensed veterinarian is **required** prior to bringing mare to our facility. Mare owner must give permission to veterinarian to share information from pre-breeding exam with stallion owner.
6. None of the above fees are refundable, however this contract includes a live foal guarantee. A live foal for purposes herein is a foal that is able to stand and nurse. If the mare does not become pregnant on the first cycle, a uterine culture may be required before re-breeding in 2023. If the pregnant mare does not produce a live foal from this breeding in 2024, rebreeding that year will be provided. Mare care fees will be the responsibility of mare owner for rebreeding. Mare owner may request that a substitute mare be permitted by stallion owner.
7. Any vet fees incurred for mare care or breeding exams are the responsibility of the Mare Owner to be paid to the veterinary facility directly. As stated above, a pre-breeding exam is required.
8. Sanderson Ranch reserves the right to reject mares that are unhealthy upon arrival, or that are determined to be a danger to Sanderson Ranch staff. If a mare is not accepted for health or safety reasons, Mare Owner will be refunded \$600. \$100 Booking Fee and \$100 Facility Prep/Staff Expense will not be refunded.
9. Sanderson Ranch will provide quality hay and a safe environment for your mare. Mare Owner acknowledges that injuries can happen and agrees not to hold Sanderson Ranch responsible for accidental injury while mare is on site.
10. Sanderson Ranch shall assist with registration of subsequent foal with Friesian Heritage Horse International if desired. Registration application submission and fee is responsibility of Mare Owner.
11. This agreement shall be construed and enforced under the laws of the State of Wyoming.
