1) A Two Hundred Dollar (\$200.00) non-refundable booking fee per mare is due with the submission of this agreement, to add your mare to the breeding schedule for STALLION. This booking fee is applied toward the stud fee listed below. Regardless of any communication regarding breeding MARE to STALLION, MARE will NOT hold a place on STALLION's breeding schedule until completed/signed contract and booking fee are received by STALLION OWNER. Contract submission and payment options are detailed within this contract.				
2) A pre-breeding veterinary exam is strongly recommended at the beginning of the breeding season including confirmation of ovarian activity (follicle production) and either uterine culture or absence of any sign of infection upon ultrasound. If veterinarian recommends a uterine culture, results will be required prior to scheduling breeding.				
3) This contract provides a live foal guarantee . Should MARE fail to conceive, abort at any time, or foal is born unable to stand and nurse and subsequently dies within 10 days of birth, MARE shall be eligible for rebreeding in 2026 or 2027 without an additional stud fee. Any additional fees such as mare care or collection/shipping expense will apply. If MARE is unable to be rebred, MARE OWNER reserves the right to substitute another mare. If rebreed is not arranged by end of breeding season in 2027, this guarantee, and this breeding contract, expires.				
4) MARE OWNER shall confirm pregnancy, or lack of, approximately 14 days after breeding via ultrasound. MARE OWNER will then notify STALLION OWNER of pregnancy status.

STALLION will be available for live cover breeding to a very limited number of mares from April 1 through September 30, 2026.

FEES AND DETAILS

- ♦ A Two Hundred Dollar (\$200.00) non-refundable booking fee per mare is due with the submission of this agreement, to add your mare to the 2026 live breeding schedule for STALLION. This booking fee is applied toward the stud fee listed on page 1. It is recommended that you contact STALLION OWNER by January 31, 2026 to tentatively add your mare to STALLION's 2026 schedule. It is also recommended that you submit this contract and booking fee by March 1, 2026 to increase your chances of inclusion of limited number of mares for live cover.
- ♦ Balance of stud fee is due prior to, or at time of delivery of MARE to Prairie Wind Ranch.
- Daily mare care is \$30 per day for mares without foals and \$35 per day with foal. There is no deduction for partial days. Mare care fees are due when mare is picked up.
- ♦ If MARE should become injured or ill while at Prairie Wind Ranch, STALLION OWNER will first attempt to notify MARE OWNER. If STALLION OWNER is unable to reach MARE OWNER and determines that emergency veterinary care is necessary, MARE OWNER authorizes STALLION OWNER to obtain veterinary services and agrees that all veterinary expenses shall be born by MARE OWNER payable when MARE is released from Prairie Wind Ranch.

MARE REQUIREMENTS

- MARE must be safe to handle by most standards. If STALLION OWNER determines that mare is unsafe for handlers
 or other horses, MARE will be sent home without refund of booking fee. Minimum mare care/facility prep fee of
 \$100 will be deducted from stud fee refund.
- No shoes allowed on MARE front or back.
- ♦ MARE must be healthy, in good condition and UTD on worming and vaccinations. STALLION OWNER reserves the right to reject any mares who display any signs of illness or unhealed injuries upon arrival.
- If MARE is accompanied by foal and the foal is over 30 days old, it is required that foal is able to be haltered and led to ensure foal's safety. If foal is less than 30 days old, foal must be introduced to human touch and usual physical restraint prior to arrival at Prairie Wind Ranch.
- If mare has ever failed to conceive with prior breedings with any stallion, a recent uterine culture may be required. This is at the discretion of STALLION OWNER.
- Prairie Wind Ranch will provide quality hay and a safe environment for your mare. Special feed or medicine that must be administered daily may result in additional fees.
- MARE OWNER acknowledges that horses can become sick or injured in any environment and waives any right to hold Prairie Wind Ranch and/or Linda Torgerson, or any agents acting for Prairie Wind Ranch, liable for any injury, death, illness, loss or damages of any kind that may occur to MARE or foal.

PAYMENT FOR LIVE COVER

- Payment in full must be made prior to breeding.
- Payment options include:
- ⇒ Personal check in the amount of \$200 made out to Linda Torgerson and mailed with this contract. Remaining \$800 stud fee may also be made by personal check at time mare is delivered to Prairie Wind Ranch. Or the entire \$1000 live cover booking plus breeding fee may be paid at the time of submission of this contract.
- ⇒ If MARE OWNER is emailing contract, booking fee of \$200 must be sent via PayPal the same day using Friends & Family option. Include your last name and name of mare in the note section. Email of torgerson588@outlook.com is also PayPal recipient name.

STALLION will be available for shipped cooled semen breeding to a very limited number of mares from April 1 through September 30, 2026.

FEES AND DETAILS

- Two Hundred Dollar (\$200.00) non-refundable booking fee per mare is due with the submission of this agreement, to add your mare to the 2026 AI breeding schedule for STALLION. This booking fee is applied toward the stud fee listed on page 1. This can be paid with personal check made out to Linda Torgerson and mailed w/contract.
- ♦ Stud fee balance of \$700 can also be mailed or can be paid via PayPal to torgerson588@outlook.com.
- Collection and shipping charges are estimated to be \$500 for each shipment. Semen can also be picked up at Red Valley Genetics, Piedmont, SD with a collection fee of \$300. These charges are to be paid directly to Red Valley Genetics and MUST be paid before semen will be collected and/or shipped. Payment details below.
- STALLION OWNER will be notified by MARE OWNER of start of MARE's cycle with regular updates of follicle size and anticipated/tentative date of semen order. Text messages (605-210-2146) work well for this information. This advance notice is for planning purposes only and will NOT be consider an official order.

SEMEN ORDERS

- ♦ Collection days are Monday, Wednesday and Friday.
- MARE OWNER or authorized representative must notify STALLION OWNER by noon MST the day before (Saturday, Tuesday or Thursday) collection/shipment of semen. STALLION owner will then tentatively schedule collection with Red Valley Genetics, LLC for the following collection day. Previous day order information can be text or voice mail at 605-210-2146.
- MARE OWNER or representative MUST confirm this order with Red Valley Genetics, LLC by 10:00 am MST on the day of collection/shipment by phone at 605-787-4808.

PAYMENT FOR SHIPPED SEMEN

- Payment arrangements must be made prior to desired collection date.
- MARE OWNER must call Red Valley Genetics at 605-787-4808 to establish a customer account prior to ordering semen. It is recommended that you do this in the month prior to the month you plan to breed. No charges will be made to your credit card until semen is ordered/collected/shipped.
- If an order for semen is placed and NOT canceled by the deadline of 10:00 am on the day of collection, your credit card will be charged even if semen is not shipped.
- Breeding/stud fee must be paid in full to Linda Torgerson PRIOR to ordering semen. This is a separate fee from the Collection/shipping fee.
- It is recommended that you have ALL breeding fees paid by the month prior to the month you plan to breed your mare.

SUMMARY

- ♦ Breeding season for WCF Sampson's Love is April 1—September 30, 2026.
- Entire stud fee must be paid in full prior to date of breeding MARE.
- It is strongly recommended to discuss breeding plans with your reproduction veterinarian in advance including a pre-breeding exam. It is also recommended to complete your annual vaccination 30 days prior to breeding.
- STALLION 2026 booking will be limited due to his age, so early submission of this contract is recommended.
- ♦ MARE OWNER must have mare examined approximately 14 days after breeding and notify STALLION OWNER of pregnancy status at that time.
- STALLION OWNER agrees to assist with registration of foals sired by STALLION by signing stallion section of registration application supplied by MARE OWNER. Completion and submission of application including payment of registration fee is obligation of MARE OWNER.
- STALLION OWNER makes no guarantee of color, gender or future performance of foals sired by STALLION.
- If STALLION dies or becomes unavailable before live foal is produced, stud fees shall be refunded with the exception of the booking fee.
- ♦ MARE OWNER agrees to make every attempt to ensure birth/health of live foal including:
- ⇒ Veterinarian confirmation of single embryo pregnancy and Caslick if recommended by veterinarian.
- ⇒ Quality feed and regular de-worming of mare during pregnancy.
- ⇒ Vaccination for Equine rhinopneumonitis (EHV-1) shall be administered to MARE at 5, 7 and 9 months.
- ⇒ Worm mare with ivermectin within 24 hours of foaling to help prevent scours in the foal.
- ⇒ Treat foal's umbilical cord a minimum of twice daily with diluted chlorhexidine until dried up.
- ⇒ It is REQUIRED to seek veterinarian assistance immediately if foal is weak or delayed in standing/nursing
